The Meeting began at 7:30 in the Terminal Board Room with V.P. Jim Manley presiding in lieu of Terri Gorman who was out of town celebrating her 45th anniversary. Congratulations to Terri and Bob!

Minutes from the General Meeting were unavailable and will be posted on the website for review.

Treasurer, Randy Wilde, distributed the financial report for the month. He pointed out that our profit/loss comparison shows that our Gen. Fund has had relatively heavy expenditures for this year. It was pointed out that we can move funds from the Ed. Fund to the Gen. Fund if absolutely necessary. The many educational functions of the Chapter were discussed. The details of the report have also been posted on our website. The report was approved as read.

It was reconfirmed that all are behind Terri's effort to order T-shirts and the new polo shirts (with pocket) for sale.

A discussion was held concerning how to better advertise and yet control the number of expected Young Eagles at future events.

Wolfgang suggested that we should definitely invite our new hanger owner, Kregg Victory, to the Christmas Dinner. It was agreed that Terri should make the invitation to Kregg ASAP. Also, getting a really
